Meeting Minutes

Wednesday 4 January 2023 at 7pm, Village Hall

Parish Councillors present: Brian Watkin (Chairman), Tony Walters (Vice Chair), Penny Ramm, Gillian White, Roger London, Simon Read, Tom FitzPatrick (District Councillor). Also in attendance: Jodie Bond (Parish Clerk). There were no members of the public present.

1. Welcome and to receive apologies for absence
