

# Sculthorpe Parish Council Annual Parish Council Meeting Minutes

Wednesday 10 March 2023 at 6.45pm, Village Hall

Parish Councillors present: Brian Watkin (Chairman), Simon Read (Vice Chair), Tony Walters, Penny Ramm, Gillian White and Ken Dawson. Also in attendance: Jodie Bond (Parish Clerk). There were 7 members of the public present.

#### 1. To elect a Chairman for the coming 12 months

The Clerk invited nominations for the office of Chairman. Cllr Watkin was nominated by councillor's present. With no further nominations it was agreed to elect Cllr Watkin to serve as Chairman for the coming twelve months. Proposed by Cllr Read and seconded by Cllr White. Cllr Watkin thanked councillors and signed his declaration of acceptance. Cllr Watkin took the remainder of the meeting as Chairman.

#### 2. To elect a Vice Chairman for the coming 12 months

The Chairman invited nominations for Vice-Chairman. Cllr Read was nominated by Cllr Dawson and seconded by Cllr White. With no further nominations, all agreed to elect Cllr Read to serve as Vice-Chairman for the coming twelve months.

# 3. Welcome and to receive apologies for absence

The Chairman welcomed those present. Apologies received from Roger London. Apologies accepted.

# 6. To report progress on items not on the agenda from the last meeting

The SAM2 Fund acceptance will be signed and witnessed following this meeting and then returned to NCC Highways. Once received the SM2 will be ordered. Cllr Read will oversee responsibility for the SAM2. Thanks, given.

Clerk enquired about the streetlights and speed limit repeaters. Highways has confirmed that 'at least 3 in total can be considered a system. Where a lighting system is in place then 30mph repeaters are not used. repeaters need to be a max of 150m apart on alternate sides, i.e. 300m apart on the same side but staggered'.

# 8. Open forum for Public Participation: an opportunity to hear from members of the public

A member of the public raised concern with cars parking on the zig zag lines outside the school. Chairman and Cllr Read directed them to the local police and suggested reporting it to the school.
